The MGCC Ulster Centre will organise a Multivenue Clubsport Joint Autotest & PCT event

on: **Saturday, 6 February 2010**

starting and finishing at: **Delamont Country Park, Killyleagh**

The event will be governed by the general regulations of the Royal Automobile Club MSA Ltd (incorporating the provisions of the International Sporting Code of the FIA) these supplementary regulations and any other written instruction the organising club may issue for the event.

MSA Permit Number: **56460** has been issued.

The event is open to all fully elected members of the MGCC or a Club affiliated to the Association of Northern Ireland Car Clubs. All competing vehicles must be fully roadworthy, taxed, MOTd and insured & comply with RAC MSA Regulations.

All competitors must produce Valid Club Membership cards at documentation.

There will be no dual entries.

The person who signs on as Driver must drive all the tests.

Scrutineering & Signing on starts at: 8.00 am SHARP

Signing on closes at 9.00 am (Exclusion if not signed on by this time)

Drivers Briefing at: 9.15 am

First car starts at: 9.30 am SHARP!

Classes are as follows:

Class 1:	Pre 1955 MG's & UVCC eligible cars
Class 2:	Post 1955 MGs and similar cars (Inc TR's, Morgans etc)
Class 3:	Midgets & Sprites without LSD
Class 4:	Midgets & Sprites with LSD
Class 5:*	Front Engine FWD, Rear Engine RWD (Minis & VWs)
Class 6:*	All Others & Road Legal Cars
Class 7:	MGFs & MGB RV8s
Class 5 & 6*	<i>Preference will be given to cars in production before 1974</i>

The committee reserves the right to refuse an entry or re-classify an entrant. **No hire cars** will be allowed to take part.

Awards will be presented at the Annual Dinner on 20 February 2010.

The maximum entry is 40, the minimum 10. The minimum for each class is 3. If the minimum number for any class is not achieved, the organisers reserve the right to amalgamate classes.

Entries open on receipt of these regulations and close on Saturday, 30 January 2010

Late entry fee after this date will be £50

The entry fee is £45.00 per non MGCC member car, £42 per MGCC member car.

An entry is not valid without the relevant entry fee attached.

A Team Entry will comprise 3 cars with an additional cost of £6 per team entered.

The Entry Fee will include tea, coffee and biscuits at the start with soup and sandwiches at the finish.

The organisers may refuse entries in accordance with B16 (RAC MSA)

The event may be postponed, abandoned, or cancelled in accordance with B16 (RAC MSA)

Provisional results will be notified as soon as possible after the event.

It is the entrants responsibility that his/her name, car & class all appear on the score card and that the score card is kept legible and in fair condition.

All protests must be in accordance with O5 (RAC MSA)

Details of the tests together with a route book will be issued with the final instructions.

Each driver must attempt each test once to count for results.

Timing will be by hand held stopwatch to the nearest 0.10 second. The starting signal will be verbal. The order of attempting tests will be numerical.

Practicing will not be allowed and may result in disqualification

Competitors will be identified by numbers provided by the organisers

Marking and penalties will be as printed in the appropriate section of the RAC MSA General Regulations, except as notified here.

The driving tests will comprise a mix of both sealed and loose surfaces.

Pylons may be less than 3 ft in height and there may be untimed/special tests.

If a team consists of more than three cars then the best three will count for team awards

Penalties are as follows:

Line fault = 5 seconds	Striking a pylon = 5 seconds	Fail	Max = fastest time in class + 30 seconds
